CRANE is a network of organisations, schools and churches working with children at risk in the Greater Kampala region. The network currently works with 134 members that have 3,462 workers who together care for more than 70,480 children at risk.

CRANE brings together child care workers, duty bearers and other stakeholders together for collaborative action for transformational change in the lives of children at risk.

CRANE has celebrated its 11<sup>th</sup> birthday and is now working towards its silver jubilee strategy to see children safe, well and fulfilling their God-given potential. We pursue 3 main outcomes:

- Children are in Families
- Children are in Safe Spaces
- Children are in Education

# Families for Children

'Families for Children' working group is a consortium of Christian organisation that work in Kampala with the focus of placing abandoned children in families.

Lillian\* was born to a teenage mother that had been impregnated by a married man. The man refused to take care of the child. The desperate mother having no means of support, abandoned the baby with Lillian's grandparents home. The grand parents later abandoned Lillian in a rabbit's house.

As some children were playing, they heard a human sound from the rabbit house. They looked in and saw a baby in there. They immediately called an adult who took the baby out. The child was found with some wounds on the ears from rabbit bites.

The adult reported the case to the local community leaders and police who took the child to a babies' home. She was one and a half years old at the time. It was from here that she was adopted by a foster family.

Lillian is now a P7 candidate and is performing well at school and relating well with her foster family.



CRANE works with babies' homes to encourage families adopt or foster a child from the institution. Our mission is to serve children whose best interest would be met by being placed in an adoptive home.

FFC is currently supporting 18 families and 19 children. One of the children was resettled with his sister where he has managed to fit in well.

During the last year, the FFC Working Group has successfully had:

an adoptive parents' training that attracted 16 participants;

3 working group meetings;

2 coffee meetings;

a 4-day business empowerment training that benefitted 14 parents;

a fun day that attracted 17 children and 13 parents;

child protection training that had 12 participants;

and a positive parenting training with 11 parents, 6 social workers and 6 children.

# Children in Education

CRANE and Viva are working together on the Girls' Education Challenge Project which seeks to benefit 9,715 marginalised girls aged 10-18, by running 20 Creative Learning Centres (CLCs) in 20 communities.

As a result, 1,990 girls will graduate from the CLCs after six months and return to appropriate education.



## creative learning centres

In the past year, 914 girls were engaged in learning in the 20 CLCs, of which 398 have graduated to either mainstream or vocational training. By March 2016 when the financial year ended, the CLC term was still ongoing, hence the difference between entrants and graduates.

Over the life of the project, 2,512 girls have been enrolled in the CLCs with 1,451 graduating to another form of learning: 923 to primary; 246 to secondary; and 282 to vocational training in skills like Early Childhood Development, tailoring, catering and hairdressing.

## teacher training

We have trained 46 teachers from the CLCs plus 21 teachers from mainstream schools as part of the CLC training.

We have also trained 20 Centre Coordinating Tutors as Trainers Of Trainees to train 400 mainstream teachers in Creative Teaching for Creative Learning; the result of which is that we have trained 666 mainstream teachers (30 from government schools and 14 from private schools) in Creative Teaching for Creative Learning.

These trainings equip school teachers with new tools and strategies to make learning more exciting, as well as equipping them

Golda\* never anticipated dropping out of school after her O level exams. She was very sure of joining A Level. However, her mother lost her only source of income.

Her father could not help in paying her fees as well. He had not supported the family before and spent the money on other women. This meant that Golda could not join

A level.

As mentors from one of the CRANE CLCs were recruiting children for the new CLC term, they invited her to join. Both Golda and the mother agreed to this.

At the CLC, Golda learnt many practical and skills such as making crafts, bags and snacks. She also learnt other life skills. Her favourite life skills activities were reading and critical thinking exercises in maths.

She has a passion for working with children and has currently joined an Early Childhood Development institute where she is training to teach nursery children.

Through the work that CRANE is doing in the CLCs with her network members, Golda and many other girls are having better life chances.





### family mentoring

55 trained mentors have been working in the 20 communities to help families take responsibility for the education of their girls, and to promote a positive attitude change towards girls' education.

Topics covered with the mentors include: child protection; community mobilisation; start and improving business; counselling; evaluation; basic computer skills; conflict management; inclusive education; record keeping and IGA development.

22 groups of parents have been formed; 16 savings groups have been established and 8 Village Savings and Loans Associations are registered their at the sub-county level.

The parents have been engaged in trainings that have focused around positive parenting, financial literacy, skills development and child protection

### mobile resource library

Our library van travels all over 5 districts, visiting the different CLCs and associated schools, lending books and resources for the girls, children and teachers.

2,099 children have used the library in the past one year, bring the cumulative total to 3875 since we started using the library van in our communities.

We have made available 6,621 books, 895 in the mobile resource library and 3,330 in the CLCs, of which 1,420 are textbooks in CLCs.

All materials are available all of the time and are borrowed by the girls and the community, including boys, girls, adults and teachers in the associated mainstream schools. This has made a significant impact on the literacy of children in the 20 communities.

### league

1,500 children have participated in the competitive league in the past year. This brings the cumulative figure to 3,225 children.

The competitive league brings children from 5 districts to compete in different activities, such as sports, debates, literacy competition and performing arts, as well as engage in community campaigns such as the roadshow dubbed "gyogereko", literally translated as "let's talk about it". The roadshow engaged

community members and leaders in dialoguing over children's rights.

The best teams and children in the league are always presented with an award. However, our aim is not to find the best but to build the children's self-esteem, as well as provide an opportunity for those that struggle academically to succeed in an alternative discipline.

We want to see the numbers of girls enrolled in school increasing, and the girls attending on a daily basis. We want the result of their time in school to be that their learning increases at a faster rate and therefore they will have more opportunities in life.

We know that for some, having extra-curricular activities is a vital part of that journey to success.



# Children in Safe Spaces

'Children in Safe Spaces' is one of CRANE's priorities. Under that umbrella, one of the projects was called 'Child, Family and Community Support'. This project worked from April 2013 to December 2015.

It worked in communities, training child ambassadors, child advocates, parents, community members and child protection committees in child protection, which is highly important in areas with high rates of child abuse.

The overall goal of this project was to see that children's rights are upheld and children grow up in a safe city.

The different targets for the project are listed below with the actual achievement by the close of the project.

child ambassadors, child advocates and child protection committees

## **1. 400 Child Ambassadors trained to speak out and educate others about child rights**

951 children were reached with protection rights messages through one day seminars.

The roadshow advocacy on 29<sup>th</sup> and 30<sup>th</sup> June 2015 attracted 151 children.



2,824 children from 24 safe clubs participated in safe club activities including music, media, debates and community outreaches in the past year. Most of the messages were on peer pressure, sexual abuse, hygiene, protection rights and life skills.

The Rights fair held in August 2015 attracted 439 children and 90 adults. During this fair, each safe club was given the opportunity to research and creatively showcase a right from the United Nations Convention on the Rights of Children to other children. This was a perfect way to crown the project as we celebrated children's rights.

## **2. 400 families describe improved access to child rights for their children in their communities**

167 parents attended seminars and learnt about protection rights.

The roadshow advocacy event on 29<sup>th</sup> and 30<sup>th</sup> June brought together 154 adults.

The Child Advocates fair was attended by 302 participants.

## **3. 40 community child protection committees established in liaison with local duty bearers.**

1,984 adults from 32 Child Protection Committees participated in child protection, joint advocacy activities, business and saving groups follow up meetings.





An advocacy television advert with the theme ‘Your Love matters most to your child: Are you a friend to your child?’ was aired on two local Television stations, Bukedde and NBS, and in 3 churches. Over 13,500,000 people watched the advert.

### Improvement in child care standards

**1. 40 CRANE members implementing national and international standards in child care.**

**2. 40 CRANE members verified in national and international standards in quality childcare.**

45 CRANE members have been verified as providing care to acceptable quality standards.

31 of CRANE members have been verified as having functional child protection and child rights policies



Ivan\* is a child ambassador and one of the leaders of the safe club in his community. During their monthly safe club planning meeting, they observed that their community was very dirty and people were just dumping rubbish anywhere. This was not a safe environment to live in.

As a safe club, they made a plan to have a community clean-up day. Before that day, they talked to the Local Council (LC) about it, who joined and participated on the actual day. The children also invited churches and community members to partner with them.

At the end of the day, the whole community expressed appreciation for what they had done. The LC issued a strict warning against reckless dumping of rubbish in undesignated rubbish pits, and now the community roads are cleaner than before.

CRANE secretariat is working with several network members to empower children through safe clubs like this one to grow up to be responsible citizens that respect the rights of others and safe guard the communities they live in.

# Children in Safe Spaces

CRANE and Viva are working together in a new 3 year project whose goal is to see that children are protected and raised in a family.

This will be accomplished by strengthening the capacity of Faith Based Organisations and churches to respond to the challenges faced by children on the streets and in homes.

The aims of the project and progress since January 2016 are discussed below.



## Community children protected from abuse

### 1. Engaging churches and community leaders in keeping children safe in communities

### 2. Empowering the most at risk families with skills and knowledge to keep children safe

We have met with 6 out of 10 senior denominational leaders in Kampala, while 23 church leaders have attended a project envisioning meeting.

6 Family Development Officers have been appointed to support churches and families, while 40 family coaches working closely with families and communities have been identified.

130 most at risk families have been identified through community mapping and a household baseline study in 13

communities.

## Children successfully living in families

### 1. Resettling children into families

### 2. Providing legal protection and developing and strengthening referral networks of child care and protection service providers

### 3. Empowering children with information and skills to help make better choices

A baseline survey in 30 community churches and 17 Child Care Institutions (CCIs) on the status of children on the street and in institutions has taken place. This also included the identification of high risk families, a head count of children living on streets, and interviews with government officials, churches and families.

In partnership with the police, 4 children have been resettled into families while 13 have been placed with Child Care Institutes where they are undergoing

rehabilitation awaiting resettlement.

## Advocacy to Government

Together with the street children working group, we are organising for the international day of street children which will be held on 12<sup>th</sup> April 2016. The street Children's Working group is leading in the 'Keep Smiling campaign' that is meant to raise awareness about the plight of children living on streets.

Nancy\* got the confidence to help a child reunite with her family after watching a TV show featuring CRANE.

She had found this pregnant 15-year old looking for work as a house help. She listened to her and came to learn that the girl had been sent away from home because her pregnancy was a disgrace to the family.

Nancy contacted the community leaders and family for a discussion, which ended with the at girl being accepted back into

# Children in Families



CRANE and Viva are working together in a 2 year project to promote family based care in Uganda with a desire to see all children living under the care of safe and secure families as God intended it.

This project has three main outcomes:

1. 20 churches trained and actively participating in family based care initiatives.
2. 20 CCIs to change practices to conform to government requirements.
3. Strengthen the network of churches and CCI ministries who learn and share together in child care

Having secured match funding for this project, we are in position to expand this work as indicated below:

1. Reduce unnecessary separation of at least 3,000 children from their families by building the social and economic strength of the family through the faith based community.

2. Reduce the number of children entering institutional care

3. Build the capacity of the faith based community to implement the Alternative Care Framework.

In the past year, the following has been achieved:

100 children have been successfully resettled with their families. Each child was given a starter pack.

Links have been created with church leaders, teachers, local leaders and Probation Officers in the communities where the children have been resettled to providing a support network for the child.

36 social workers and 19 CCIs have

been trained in family therapy, child development and counselling, parenting skills; and neural linguistic programming for a total of 25 days.

47 pastors and Christian ministry leaders were hosted in a one day conference held in November 2015. The key objective of this conference was to engage and raise awareness to church partners on their role and Biblical mandate to care for children and challenge them to call their congregations to embrace family based care as opposed to institutional care for children.

34 child protection committees have been formed in the church communities where we are working.

The 'Street Children's Working Group' hosted a Christmas Party for children living on streets in December 2015.

# Maternal and Child Health

'Beginnings' is the maternal and child health project in Kampala run by CRANE in partnership with Viva and Community Health Global Network.

This project seeks to improve maternal, new-born and child health in two urban slum communities by increasing coverage of 9 key measurable evidence based community health practices and interventions.

Through peer-to-peer training, reaching men and improving access to health services, the overall aim of the 'beginnings' project is that women and children improve their health behaviours and have better access to simple health care interventions, leading to better health and health care in the slum communities of Bwaise and Namuwongo.

In the past year, the 21 peer educators were engaged in 11 trainings. They were taken through various health topics with a special emphasis on immunization, nutrition, first aid, HIV/AIDs, good sanitation and couple counseling.

The peer educators were able to reach 20,393 adults and children in the slums of Bwaise and Namuwongo. Although there were cases of some community members not accepting the messages that they were sharing, such as family planning, the majority of



those contacted had a positive response to their teaching.

A situational analysis survey was carried out in July 2015 to comparatively assess the progress made since the onset of the maternal and child health project.

This research targeted parents or guardians of children 5 years and below. After analysis of the results, it was found that there had been a great improvement in the health practices of the respondents in the two communities.

The improvements were seen in the following: vaccinating children; children sleeping under a mosquito net; knowledge of 3 the signs that children need medical attention; increase in antenatal visits; increase in numbers giving birth in hospitals; and a slight increase in the use of different family planning methods.

Some of the peer educators are

helping in the economic empowerment of young mothers whom they are teaching skills like cake baking, beads making which can be extra sources of income.

The Peer Educators have also organised weekly seminars supported by Alive Medical Services through which they give out free mosquito nets.

Young people have been engaged in discussions about HIV/AIDs and how to guard against acquiring it.

The Peer Educators have challenged most of the health workers in their communities to improve the quality of their service delivery which has forced them to change the way they attend to the patients that visit their facilities.

Immunisation of children has improved partly due to peer educators helping to mobilise the community



# Message from our Treasurer



While I have been on the CRANE Board, we have made huge strides, but we must keep looking forward because the task is so big, we are barely scratching the surface of helping children at risk.

We are grateful to God for all He has provided in the last year for the network. We have continued to grow our income and to expand the activities of the network. Our income has grown by close to 50%, which the activity report reflects as well.

We desire to excel in every program we are involved in for the welfare of the children. We should always see at the end of the money and activity chain a child whose environment and whose life are brighter today than they were yesterday.

The total income received by the network for all activities was UGX 3,290,019,728 in 2015/16 compared to UGX 2,103,544,103 in 2014/15 Expenditure was UGX 2,795,005,040 compared to UGX 2,040,932,835 in 2014/15.

CRANE general funds, which are mostly unrestricted funds, totalled UGX 130,267,955 income compared to UGX 117,852,954 in 2014/15 and 93,305,674 UGX expenditure, compared to UGX 117,852,954 respectively. Of the income received, 7,050,000 UGX came from members as member fees. The expected amount should have been 11,200,000/- for the year. The cumulative pending receivables from members currently stand at 24,735,428 UGX.

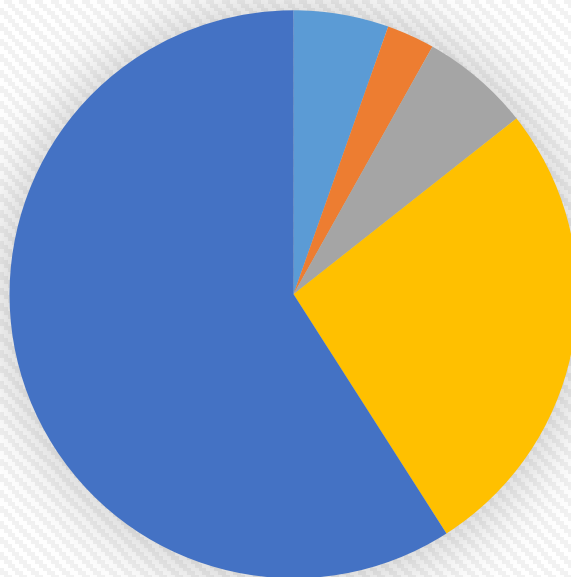
The desk space income collected from programme funded the operational costs of the office. This is donor related income. Given that this is the biggest source of income for running the office, there is a need to reconsider how to secure core running costs. Other incomes include local collections from printing and mileage. The board should work with members and the secretariat to devise strategies for increasing general funds. This will enable the network to invest in long-term structures such as land and offices to contribute to the sustainability of the organisation.

A number of members have not cleared their arrears. This part of our budget and income needs a lot of improvement. I know that member organisation make significant inputs in the programmes at the local organisational level. However, we need to understand that member's organisations are responsible for the sustainability of their network. A reasonable membership contribution communicates to potential funders that we have a stake in our network. It is one of rallying points for maximising our bargaining power to potential funders. We therefore urge members to meet their obligations.

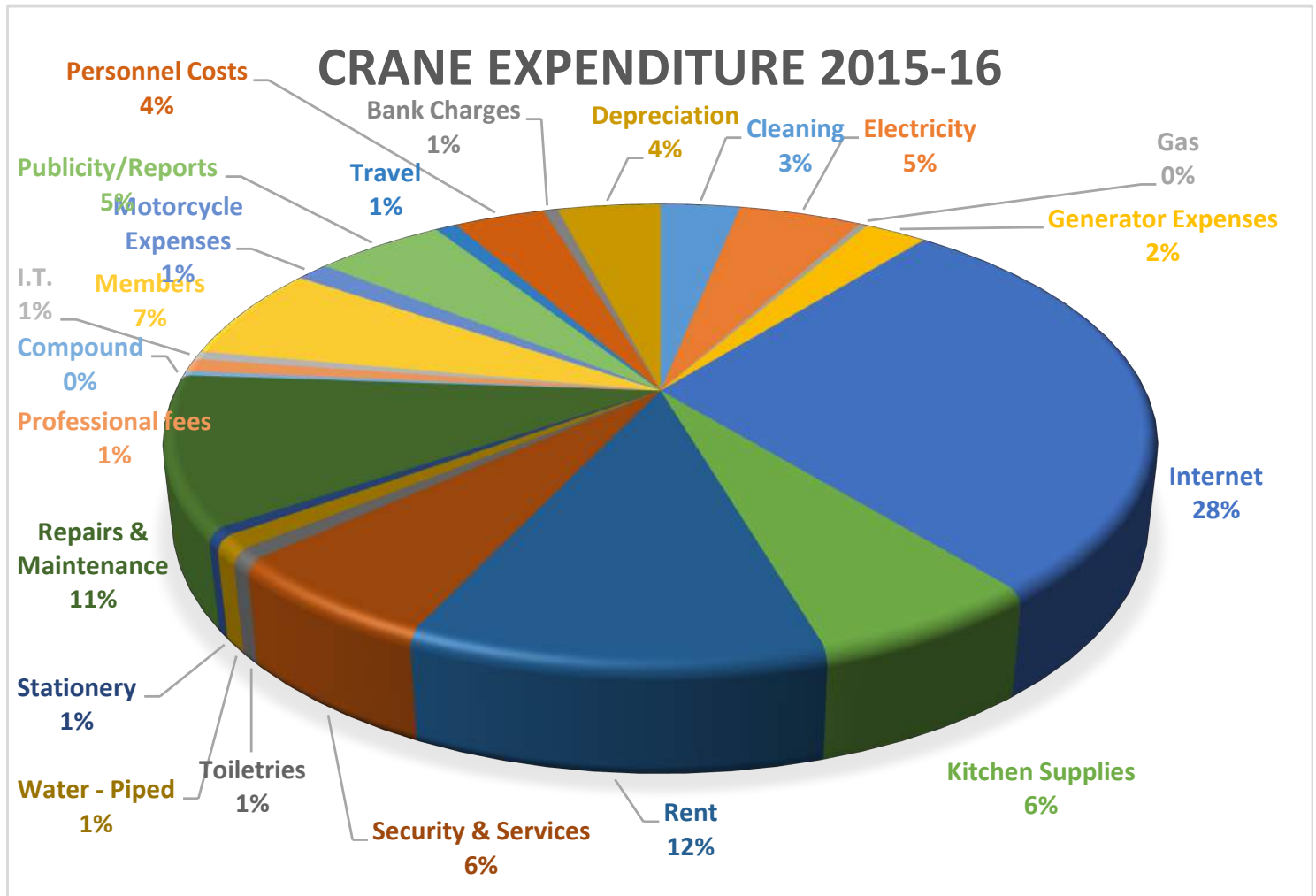
